Role purpose:

The Building Maintenance Engineering Surveyor will be responsible for providing a building maintenance and surveying consultancy service.

Accountabilities:

- 1) Inspect allocated properties in accordance with set frequencies, identifying and dealing with building and engineering maintenance items on a prioritised basis.
- 2) Complete planned works programme to cost and within time frames.
- 3) Complete the annual update of condition surveys in accordance with set time frames.
- 4) Prepare reports etc., in compliance with technical and contractual requirements including, where necessary, for working/using building management data systems and the use of iPads for uploading and input of data.
- 5) Carry out property inspection and the identification of servicing, day-to-day and planned repairs, and future replacements to mechanical and electrical installations.
- 6) Demonstrate both Mechanical & Electrical qualification/knowledge even if there may be a bias in either Mechanical or Electrical Engineering
- 7) Consult with relevant parties on the implementation of repair and improvement projects.
- 8) Promote a professional property service on behalf of the NPS Group to official representatives and external clients at all levels.
- 9) Promote the NPS Group as a property consultancy services provider to external clients.
- 10) Responsible for identifying new business opportunities.
- 11) Fee earning at 90% and contribute to the achievement of business plan objectives and targets.
- 12) Carry out duties appropriate to the grade of the post, including occasional travel to other offices and sites as required.
- 13) Promote continuous improvement and deliver demonstrable high-quality products and services which embrace quality standards.
- 14) Demonstrate personal commitment to the Norse Way CSR strategy.
