<b>The Role:</b>

Caretakers are to provide a safe environment for the users of the buildings at all times.

<ul style="list-style-type: none"> <li>• Follow signing in &amp; out procedure.</li> <li>• Supervision of cleaning staff</li> <li>• Carrying out day-to-day maintenance and minor repairs – carry out compliance checks in line with building regulations</li> <li>• Making sure that heating, lighting and alarm systems are working properly</li> <li>• Making sure that doors and windows are locked when the building is not in use</li> <li>• Checking the premises to guard against vandalism or break-ins</li> <li>• Opening up the building in the morning and locking it at the end of the day</li> <li>• Arranging chairs and tables for meetings and clearing away afterwards</li> <li>• ordering cleaning materials, new equipment and furniture</li> <li>• Carry out routine and non-routine (if applicable) cleaning duties in accordance with the cleaning specification and required standards as required</li> <li>• Comply at all times with Health &amp; Safety regulations and abide by the Health &amp; Safety training provided.</li> <li>• Maintain high levels of customer service.</li> <li>• Ensure the correct PPE is worn at all times whilst on duty.</li> <li>• Demonstrate Norse values at all times.</li> <li>• Report faulty machinery and possible Health &amp; Safety hazards to supervisor.</li> <li>• Undertake specified training and development as required.</li> </ul>
